Date	Development of the Knoxville BMP Manual
February 1999	Camp Dresser & McKee, Inc. (CDM) begins work on the Knoxville BMP Manual.
March 2000	The draft BMP Manual is completed by CDM & given to Knoxville Engineering Department.
August 2000	Placed the first portion of the BMP manual onto website. (main text, AM)
January 2001	Placed two additional sections of the BMP manual onto website. (main text, AM, ES, IC)
<b>March 2001</b> ★	Placed another section (ST) of BMP Manual onto website. The local engineering community is notified by letter and in the annual Engineering Development Seminar. <b>The Knoxville BMP Manual is now ready for use.</b> Please reference the publish date as “March 2001”.
August 2002	Revised ES-01 (Stabilized Construction Entrance) only.
<b>May 2003</b> ★	<b>Extensive revisions</b> to match the revised Stormwater & Street Ordinance, the new NPDES municipal permit, the Knoxville Land Development Manual, and other state/federal regulations. Another section of BMPs (RH) is added. (main text, AM, ES, IC, RH, ST)
July 2003	Revised ES-29 (TDOT Standard Details for Erosion Control) only.
June 2006	Added a new Special Pollution Permit Application specifically for Food Handling and Processing Facilities (restaurants, grocery stores, food services, etc.).
April 2007	Added 3 Special Pollution Abatement Permits for <b>Vehicle and Equipment Facilities</b> (vehicle and equipment dealerships and storage facilities, fueling stations, repair shops, etc.), <b>Vehicle Wash Facilities</b> (car washed, etc.), and <b>Large Parking Lot Facilities</b> (large parking lots, warehouses, etc.)  Revised the Special Pollution Permit Application specifically for Food Handling and Processing Facilities.
October 2007	Revised ST-01 (Dry Detention Basin), ST-02 (Wet Detention Basin) and ST-10 (Detention Computations).
October 2009	Revised ES-24 (Temporary Inlet Protection).
January 2010	Revised Chapter 8 (List of Related Websites).
May 2011	Revised ES-14 (Silt Fence).
