Release of Liability and Indemnification Agreement

I understand that the act of unleashing my dog(s) and being physically present inside the pool area necessarily involves risks of injury to me, to other people, to my dog(s), and to other dogs. I understand these risks are entirely my responsibility. I expressly assume these risks. I am aware of the risks and hazards inherent upon entering the pool area and I choose to voluntarily enter the premises, knowing the conditions might become more hazardous and/or dangerous for myself and/or dog(s) and I voluntarily assume all such risks, loss, damages, or injury that may be sustained by entering the pool.

By signing this release of liability and using the pool, I hereby fully and forever release and discharge the City of Knoxville and their volunteers, employees and agents from any claims, demands, damages, rights of action or causes of action present or future, whether the same be known or unknown, anticipated or unanticipated, resulting from or arising out of my use or intended use of the pool. I fully and forever release and discharge the City of Knoxville and their employees and agents from any and all negligent acts and omissions in the same.

By signing this agreement I also agree to indemnify the City of Knoxville and their volunteers, employees and agents from any claims, demands, damages, rights of action or causes of action present or future, whether the same be known or unknown, anticipated or unanticipated, brought against any or all of such entities based on my use or intended use of the pool.

I have carefully read this release of liability and understand and fully agree with its contents.

Rules for Doggie Dip

1. One dog per one human owner. Each dog must have a registration form filled out.
2. All dogs must be current on their vaccinations.
3. Your dog may be released from their leash upon entering the pool deck area.
4. No children under the age of 16 are allowed without adult supervision.
5. Your dog must remain under your control at all times. Know your dog's personality. If he/she is acting aggressively, or overly affectionate please wait until you can calm him/her down before unleashing. If your dog continues to act aggressively, or overly affectionate you and your dog will be escorted from the event.
6. Please be sure your dog has been exposed to swimming. Some dogs swim well, some don't. If not, he/she may become afraid or aggressive.
7. Owners must dispose of their dog's fecal matter.
8. Please help your dog into and out of the pool. Volunteers will be on hand if you need assistance.
9. Use of diving boards is allowed.
10. Be courteous to other guests and clean up your dog's "accidents."
11. Female dogs "in season" are not allowed.
12. Do not bring dogs that have health conditions that may endanger themselves or others.
13. Humans are not allowed in the pool.
14. Outside food or drinks (pet or human) are not allowed in the pool area.
